LOCATION.--Lat 26°40'06", long 81°53'44" referenced to North American Datum of 1983, Lee County, FL, Hydrologic Unit 03090205, located in middle of channel attached to bridge piling for Pondella Road, 1.1 mi from the mouth, 2.3 mi northwest of Fort Myers.

DRAINAGE AREA.--Indeterminate.

SURFACE-WATER RECORDS

PERIOD OF RECORD.--

DISCHARGE: April 2008 to current year.

GAGE HEIGHT: April 2008 to current year.

REVISED RECORDS.--WDR-US-2010, site 264006081534400: 2008, 2009; gage height daily values tables and extremes revised to NAVD 88 datum.

GAGE.--Satellite data collection platform with water-stage vented pressure, and acoustic Doppler velocity meter. Datum of gage is North American Vertical Datum of 1988 (NAVD88). (Revised).

REMARKS.--Records fair, except for days of estimated daily discharges, which are poor. Streamflow at this site is affected by astronomical tides. Daily mean discharge was computed from filtered unit value discharge data. The Godin low-pass filter is used to remove principal tidal frequencies from unit values. Positive discharge (ebb tide) is generally to the southeast direction, and negative discharge (flood tide) to the northwest. DISCHARGE: Maximum positive discharge (unfiltered) 685 ft³/s Aug. 18, 2009; maximum negative discharge (unfiltered) 597 ft³/s Sept. 3, 2009.

GAGE HEIGHT: Maximum recorded 2.23 ft Sept. 10, 2008; minimum recorded -2.64 ft, Jan. 16, 2009.

EXTREMES FOR CURRENT YEAR.--

DISCHARGE: Maximum positive discharge (unfiltered) 468 ft³/s July 17; maximum negative discharge (unfiltered) 413 ft³/s Dec. 20.

GAGE HEIGHT: Maximum recorded 1.78 ft Sept. 6; minimum recorded -2.43 ft, Jan. 13.




